#### Next Meeting:

Next EPBF Board meeting was appointed to Paris, France on 9.January 2012.

Item #1 on the Agenda: EPBF Statute and registration, reported by Laurent Hamet.

L. Hamet presented the latest version of the EPBF Statute and proposed to read and to agree each Statute section separately.

## Corrections made per section:

- 1. Section #3 of the Statute "Headquarters official languages". For the Headquarters address should be written only country (France) and city name. Bruno Lemaire is to provide the new address of French Federation office.
- 2. Section #11 of the Statute "Voting".

The following voting system had been formed:

"Every affiliated country has a right to have up to 3 votes based on the number of its members.

The Founder member has a right for the following votes:

- 1. Laurent Hamet 5 votes;
- 2. Barry Fuggle 5 votes;
- 3. Ulrich Staehr 5 votes;
- 4. Manfred Ulrich 5 votes;
- 5. Stephen Baldwin 5 votes;
- 6. Tomasz Matuszewski 3 votes:
- 7. Viktor Tohayev 3 votes;
- 8. Patrice Guigou 3 votes;

9. Wolfgang Kornholz – 3 votes.

The Founding member status expires at the 12 anniversary."

The system has been put to a vote. Voting results:

Yes: 8 persons. Against: 1 person. Upstain: 1 person.

Approved by the majority.

**To be approved by the Congress in 2013:** Affiliated Federation Members can have the additional votes up to a maximum of 3 as determined by a proportional account of recognized validated members of their Federations.

3. Section #12 of the Statute - "Operation".

New edition, approved by a solid vote: "The EPBF Congress shall take place once in a year."

4. Section #13 of the Statute - "Validity of decisions".

New edition, approved by a solid vote: "It was decided However, for decisions to take effect the Congress must be composed of at least half the members having the right to vote".

5. Section #19 of the Statute - "Structure, powers and operarion".

New edition, approved by a solid vote:

"The Executive Board of EPBF is composed of:

- the EPBF President;
- the General Secretary;
- the Treasurer:
- the Senior Vice-President;
- the 5 Vice-Presidents."
- 6. Section #20 of the Statute "The President, his election and his role".

New edition, approved by a solid vote: "If, for whatever reason, the post of President becomes vacant, the Senior Vice-President fulfills his duties. If, for whatever reason, the Senior Vice-President cannot take over, then the Executive Board of EPBF shall elect, by secret ballot, one of the Vice-Presidents as Provisional President, and elect a new President at the next earliest Congress session."

7. Section #21 of the Statute - "The Senior Vice-President".

New edition, approved by a solid vote: "The Senior Vice-President represents the President in his absence at meetings and when the post becomes vacant."

8. Section #24 of the Statute - "The Comissions".

New edition, approved by a solid vote:

"The EPBF commissions are as follows, but not limited to:

- Rules, Referees, Disciplinary and Ethic commission,
- Technical, Development and Finance commission,
- Control and Revision commission.
- Competitions commission."
- 9. Section #26 of the Statute "International events".

New edition, approved by a solid vote: "A fine can be applied to National Federations not having paid on time the appropriate competition fee."

### Resolved:

- 1. The approved corrections are to be included in the EPBF Statute.
- 2. The EPBF Statute is to be registered not later than in 1 month after the meeting.
- 3. Laurent Hamet is responsible to control the EPBF Statute registration process.
